


Approx. 74% of all patients seen at Robbinsdale Hospital are on government programs.

For years, we have not made up our costs on caring for these patients.


- For patients with the government as their payer, we spend more than we get paid.
- For patients with commercial payers, generally, we get paid more than we spend.
- The financial gap is created by the difference between these two, particularly when the net effect is that we lose more than we make caring for all patients we see.

Newborn nursery care transition

Robbinsdale Hospital lowered its newborn nursery level from Level 2 (special care nursery) to level 1 (well newborn nursery).

With this change, we have confidence in our short-term plan, which is backed with a commitment for the long term.


