MN.TRAIN details

MDH FPLS uses the MN.TRAIN system for FSP and FSP+ contact hours.

Pre-register at MN.TRAIN (www.train.org/mn) if you want to receive a continuing education certificate for:

- REHS/RS
- Minnesota CFPM

Here's how:

- 1. Set up a user account if you don't already have one. Anyone can create an account in MN.TRAIN. There is no cost. (State employees should already have an account.)
 - A. Go to MN.TRAIN (Google Chrome works best) and click on "Create an Account" on left side of screen beneath the Login button.
 - B. Review MN.TRAIN policies and check the "Agree" box. Click "Next."
 - C. Enter all required profile information. Click "Next."
 - D. If you are NOT a state employee, click the "Select Groups" button and select "Not a State Employee." Select the region where you live, and the county in which you work.
 - E. Select ODP discipline (the field in which you work). Click the "Submit" button below the map.
- 2. Register for the course (see Course ID# on page 1).
- 3. After the event, log back in to mark your course "completed" and save or print your contact hour certificate, if desired. You can also store your certificates on your <u>MN.TRAIN</u> account, and print a transcript later.
- 4. Questions or problems with your account? Email MN.TRAIN.
