- Provide a copy of Micha Wekenborg-Tomka's credentials; or
- Complete and provide another Minnesota REHS/RS Supervised Employment Verification Form from Olmsted County or another employer after Rebecca's one year of qualifying supervised employment has been reached.

If Rebecca is unable to provide a copy of Micha Wekenborg-Tomka's credentials or a completed Minnesota REHS/RS Supervised Employment Verification Form after her one year of employment has been reached, Rebecca will not be allowed to sit for the exam due to disqualification because she was unable to meet the requirement of 4695.2700, Subpart 1, B.
