

MLS Laboratory Update: Notice of Intent to Adopt Proposed Changes to Communicable Disease Reporting Rules

Purpose of this Message:

To inform MLS laboratory partners about the *Notice of Intent to Adopt Proposed Changes to Communicable Disease Reporting Rules*.

Please review the following information. All interested persons are encouraged to comment per process described below. Deadline is June 12, 2024 at 4:30 pm.

Background:

The Minnesota Department of Health (MDH) has formally proposed updates to the communicable disease reporting rules through the rulemaking process and published the Notice of Intent to Adopt on May 13, in the *State Register*. You can submit written comment in support of or in opposition to the proposed rules or any part or subpart of the rules to the Office of Administrative Hearings (OAH) Comments on Rules - 39948 Minnesota Department of Health Dual Notice of Intent to Adopt Rules

In addition to submitting comments, you may also request that the Department hold a hearing on the rules. If MDH receives 25 or more written requests for an administrative hearing, a hearing will be held on Tuesday, June 25, beginning at 9:30 a.m.
