Minnesota's [Early Childhood Screening program \(dcyf.mn.gov/programs-directory/early-childhood-screening\)](http://dcyf.mn.gov/programs-directory/early-childhood-screening) is targeted for ages 3-4 years; this screening is required prior to public school kindergarten or first grade entrance, and for eligibility for Early Learning Scholarships, School Readiness, and Voluntary Prekindergarten if not done previously.
2. Head Start and Early Head Start [screening and assessment standards \(headstart.gov/policy/45-cfr-chap-xiii/1302-33-child-screenings-assessments\)](http://headstart.gov/policy/45-cfr-chap-xiii/1302-33-child-screenings-assessments) and programs follow state EPSDT guidelines.
3. [Child and Teen Checkups \(C&TC\) \(mn.gov/dhs/people-we-serve/children-and-families/health-care/health-care-programs/programs-and-services/ctc.jsp\)](http://mn.gov/dhs/people-we-serve/children-and-families/health-care/health-care-programs/programs-and-services/ctc.jsp) is Minnesota's Early and Periodic Screening, Diagnosis and Treatment (EPSDT) Program for Medicaid (0-20 years).
4. [Family Home Visiting \(www.health.state.mn.us/communities/fhv/index.html\)](http://www.health.state.mn.us/communities/fhv/index.html) programs (through state and federal funding) provide services, prenatal to 3 years.
5. Minnesota's [Follow Along Program \(www.health.state.mn.us/people/childrenyouth/fap/index.html\)](http://www.health.state.mn.us/people/childrenyouth/fap/index.html) is a local public health screening program targeted for children ages birth up to 3 years.
6. Mental health professionals in Minnesota's [Early Childhood System \(mn.gov/dhs/partners-and-providers/policies-procedures/childrens-mental-health/early-childhood-mh-system-care\)](http://mn.gov/dhs/partners-and-providers/policies-procedures/childrens-mental-health/early-childhood-mh-system-care) provide developmental screening as a part of their assessment for young children.
7. Child welfare services provide social-emotional or mental health [screening \(mn.gov/dhs/partners-and-providers/policies-procedures/childrens-mental-health/screening\)](http://mn.gov/dhs/partners-and-providers/policies-procedures/childrens-mental-health/screening) to children in child protective services or out-of-home placement.
