The information included here is important for your family because your baby was born with a health condition that we track in Minnesota. We hope the information in this packet will answer your questions so your family can grow and thrive!

Who we are



The Children and Youth with Special Health Needs (CYSHN) program of the Minnesota Department of Health (MDH) works to provide positive health outcomes for children and youth who have, or are at risk for, special health needs, and to better serve their families.

The health conditions we track

We keep track of certain conditions that babies can be born with. Sometimes these conditions are minor, but many are very serious. It is possible for babies to be born with more than one of these conditions. See a full list of the conditions we track in the insert of this packet.



Why we track these conditions and what information is kept

We keep this information so we can watch for trends or high numbers that might be a concern. These patterns can help us identify causes and prevent these conditions for future births.

The information in the database is carefully protected. It is not public. We only report information as “aggregate data.” This means that all numbers are shown as a group, not individuals. For example, we could report the percentage of babies born in Minnesota with cleft lip in 2017.



The database includes these types of information:

- Date of birth.
- Location of birth.
- Specific birth condition(s) and how it was diagnosed.
- Contact information.
- Demographics of mother and baby (like age, race, ethnicity).



How we can use this information:

- Report how many babies were born with a condition and describe patterns and outcomes.
- Ask local public health nurses to contact you and help with resources.
- Provide resources and other information.
- Discuss complicated conditions with medical specialists to accurately report the condition.
- Partner with other programs serving children and youth with special health needs at MDH.
- Contact you about research opportunities to see if you are interested in being involved.
- Collaborate with researchers on approved projects.
- Evaluate and improve our program.



Removing your information

You have the option to remove your baby’s name and identifying information from our program’s database. This is called “opting out.” Identifying information includes all names, contact information, and specific date of birth for the mother and baby.

If you choose to remove your child’s information from our database, you can get the required opt-out form on our [Birth Defects Monitoring and Analysis webpage \(www.health.state.mn.us/birthdefects\)](http://www.health.state.mn.us/birthdefects). At the bottom of the page, expand the section labeled “Additional Information”, select “Opt-Out form for the Birth Defects Information System,” then follow the instructions on the form to complete.

Your local public health department can answer questions you have related to financial help, child development, and more.
