## **Introductions and Welcome**

Catherine Lloyd will be providing some context for these meetings pre-COVID and today.

Last meeting was 01-16-2020; we are happy to restart after the long hiatus. Commissioner's duties are laid out in Chapter 149 A specifically 149.03 to evaluate laws, rules, and procedures regulating the practice of mortuary science, to revise the standards for licensing, and to improve the regulatory and enforcement methods and to initiate proceedings to address and remedy inconsistencies in the laws, rules and procedures.

The ad hoc committee started when we were developing alkaline hydrolysis facility licensing standards and continued with other issues as they presented.

In 2019 HRD revised our purpose to provide our perspective on the industry.

- 1. Professional Licensing and regulation
- 2. Facility licensing
- 3. Scope of practice

- 4. Investigation and
- 5. Licensing administration by HRD

Voted on clinical standards, labor shortages, scope of practice, baccalaureate standards, internship, apprenticeship, dual licensure, crematory licensure, standards within industry, pre-need, green burials, community standards, refrigeration, cultural issues, direct burials.

Do we need more info about death doulas?

Our goal then was to expand on statewide engagement activities. Find out what is happening in the industry and where the gaps are that need to be addressed.

We want to think about what we've learned and what the pandemic taught us.

- Who is missing from the conversation?
- Dealing with ambiguous loss. How did that affect your business?
- Multicultural groups are important too and we'd like to reach more of them.
- Words like trauma keep coming up.

The Mortuary Science Section of the Minnesota Department of Health initiated an ad hoc committee in 2014 to strengthen communication with the industry and to discuss issues pertaining to regulation that affect practitioners, their clients, the public, and MDH as the regulatory body.

- Evaluator Updates: Complaints, Investigations, and Letters of Non-Contagious
- Erika Fulgern Since Jan 2020 we have 40 active investigations

- Carlena Weiland investigations
  - Letters of non-contagious require embalming reports and don't have all of the information required for statutory requirement.
- Legislative Update from Daphne Ponds MDH asked to provide comments for HF 3466 Human Composting bill. MDH suggested some additional language regarding disposition. HUOT bill brought forward needs to be brought by a legislator. There is a lobby regarding this issue. Death certificates are getting to be a mess; waits are 6-9 months. 120 days to get a death certificate from funeral home directors. Some states have "shell issue laws" after a # of days the medical examiner is responsible.

Promession freeze drying burial. Used in Scandinavian countries.

Sansa and Continuing Education (Alison Helm): Big change this year. We no longer approve providers or courses to meet the CE requirement. People can submit what they feel meets the requirements. If approved by the academy that would be recognized by MDH. We may question reasoning as to why the course fits into a CE category.
